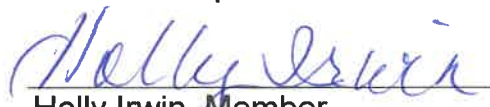

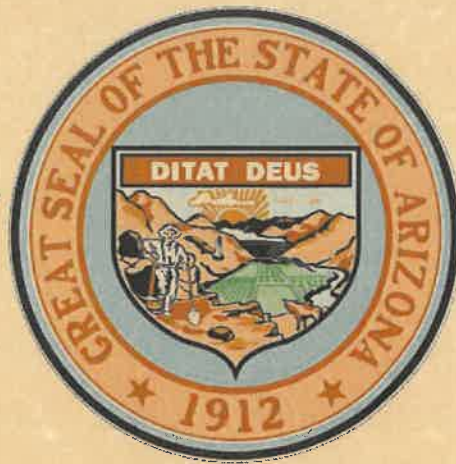

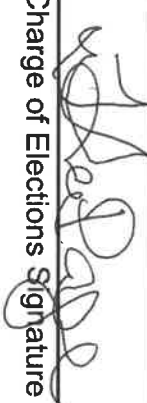

Secretary Fontes:

Pursuant to A.R.S. §16-602, La Paz County conducted a Hand Count Audit of July 21, 2026, Primary Election.

The hand count began on July 22, 2026 at 1:00 p.m. when the La Paz County Chairmen of the Republican and Democratic Parties met to select the races, vote centers, and early ballot batches to be counted.

The selection order was chosen by lot, and the Democratic Party was chosen to go first. With the order established, the following vote centers and early ballot batch were randomly selected: Parker 51, Poston 52, and Early Ballot Batch 18.

Four contested races were selected randomly by the party chairs as required by law for the Hand Count. The following is the list of contested races that were selected:

Legislative: State Representative District 30 (REP)
Statewide: Superintendent of Public Instruction (REP)
Statewide: Corporation Commissioner (REP)
Statewide: Superintendent of Public Instruction (DEM)

The physical hand count started at 1:00 p.m. on July 27th and was concluded that day at 4:00 p.m. The tabulation method used was the stacking method. The hand count was conducted by two boards made up of 3 members each, of which not more than 2 members were from the same political party.

Attached are the early ballot and vote center hand count worksheets, which depict the results of the hand count audit for each race. I am happy to report that the hand count audit totals matched the machine tabulated results perfectly, with no discrepancies.
