Secretary Fontes:

Pursuant to A.R.S. § 16-602, the Cochise County Elections Department conducted the statutorily required hand count audit of the July 21, 2026, Primary Election. Cochise County tabulates Election Day ballots cast onsite at each Vote Center. All eighteen Vote Centers were included in the random draw for selection. Two Vote Centers were included in the random draw for selection. Early ballots were tabulated at Central Count using two tabulators, the County's two D950s. Ten batches of approximately 200 ballots each were sequestered for the random draw.

The Cochise County Party Chairs from the Democratic and Republican Parties provided the required six names, with alternates, to the Elections Director by the statutory deadline. Democratic Party Chair Robert Karp and Republican Party Chair Judy Smith who met at 2:00 p.m. on Wednesday, July 22, 2026, at the Elections Department to begin the hand count audit process. They randomly chose, by lot, the following Vote Centers and early ballot batch:

- Vote Center 14 – McNeal: 62 ballots cast
- Vote Center 10 – Sierra Vista: 303 ballots cast
- Batch #4 – 200 early ballots cast

Twelve hand count audit board members—six each from the Democratic and Republican Parties—convened at 9:00 a.m. on Saturday, July 25, 2026, at the Elections Department to begin the hand count audit. Following the administration of the Oath to all present and providing detailed instructions by the Elections Director, the physical hand count began. The aggregate hand count report, signed by both Political Party Chairs (or their representatives), which depicts the results of the hand count audit for the July 21, 2026, Primary Election, is attached along with the hand count summary report for each Board. Ballots were compared to the machine-determined results, with 100% accuracy.
