RE: Hand Count Report – July 21, 2026 Primary Elections
DATE: July 26, 2026

Pursuant to A.R.S. §16-602(B), Santa Cruz County conducted a Hand Count for the July 21, 2026, Primary Election.

On Wednesday, July 22, 2026, at 3 pm, the Elections Director conducted a random drawing of lots for early ballot batches to be counted during the Hand Count Audit. Under Arizona law, the hand count audit of early ballots needed to include at least 1% of early ballots cast in Santa Cruz County. The number of early ballots cast during the random selection were 5,260. Two batches of 50 and 51 early ballots were counted for the total Hand Count Audit of early ballots with the percentage of 1.92%.

The drawing for Hand Count Audit early ballot batches was conducted by lot by the County Political Party Chairs or Designees and only one machine (DS950) was used for the tabulation of Early Ballots. Prior to drawing the lots with the assistance of the Party Chairs or Designees, a coin toss determined which party (Democrat or Republican) would draw the first lot. The County Chairs or Designee selected by lot tabulation batch numbers between A0001 and A0109. The range of the lot numbers was based on the number of early ballot batches that had been received from the Records Office after their verification process. Subsequent lots were drawn alternatively by the Party Chairs or Designees according to party affiliation. The following batches were selected:

- **Tabulation Machine A (DS950) - Batch A0007 (50 ballots)**
- **Tabulation Machine A (DS950) - Batch A0096 (51 ballots)**

The ballot batches were sequestered, from the same machine, as only one machine was used to tabulate Early Ballots as selected and reported above.

After the Early Ballot selection, the selection of two polling locations randomly selected for the hand count were:

- **VC 5 – Patagonia Cady Hall**
- **VC 12 – SCC Provisional Community College**

The County Party Chairs or Designees also selected the races to be counted for those categories with at least one contested race, up to five contested races in priority order, i.e., Statewide Candidate races and State Legislative (Senate or House) races. The district number was included for the Legislative category because the other district did not have contested races.

Conducting the Hand Count

The Hand Count boards met on July 24, 2026. **There were two boards made up of three members; one board had one Democrat and two Republican, and the other board had one Democrat, one Independent and one Republican.** Each board had an alternate available should the need arise. The stacking method and the calling method was used for counting.

The batches of early ballots were tabulated on one machine only; therefore, the hand count provides information on the tabulation accuracy of one machine. **The hand count results matched the tabulated results; there were 0 (zero) discrepancies.** The results are shown in the tables below:

As stated above, the Election Day ballots for two (2) Vote Centers were hand counted. **One discrepancy was identified for Vote Center 12 and is highlighted in yellow in the table below. Vote Center 5 had no discrepancies between the hand count and the machine tabulation.** The results are shown in the table below:

The discrepancy percentage is calculated as follows: **Absolute Difference ÷ Machine Count × 100**. In this case, the discrepancy is **3.125% (1/32 × 100)**. Although the percentage exceeds **1%**, the actual discrepancy is **only one (1) vote**, which is **below the designated margin of three (3) votes** established by the Arizona Vote Count Verification Committee. Therefore, no expanded hand count audit is required.

The one-vote discrepancy resulted from a ballot on which the voter marked the choice with slashes rather than completely filling the target oval. The Hand Count Board determined the voter's intent was clear and counted the vote manually, while the tabulation equipment did not record the mark. The discrepancy is below the Vote Count Verification Committee's designated margin and does not require an expanded audit pursuant to A.R.S. § 16-602.

INSTRUCTIONS FOR RANDOM SELECTION OF VOTE CENTERS AND EARLY BALLOTS FOR HAND COUNT

July 21, 2026 – Primary Election

These instructions are intended to assist election staff in selecting and sequestering **Vote Centers and Early Ballots** for the hand count required for the July 21, 2026, Primary Election. This document will also serve as certification of the method used to select both Vote Centers and early ballots for hand count purposes.

On **July 22, 2026 at 3:00PM**, the Elections Director will flip a coin to determine which County Political Party Chair Democratic or Republican will make the first lot selection of Vote Centers. Two Vote Centers will be randomly selected, as this number exceeds 2% of the total Vote Centers used. The selection process will then continue with Early Ballot batches.

The **opposite Political Party Chair** (the one who did not make the initial Vote Center selection) will begin the random selection of two batches of early ballots that have already been tabulated. These are early ballots that have been tabulated up to Election Day. Once selected, these batches will be sequestered along with their corresponding unofficial tally reports for review by the Hand Count Board.

Only tabulating machine, A (DS950) is used for early ballot processing. The batches will be selected as described below. The number of early ballots to be hand counted complies with **A.R.S. § 16-602(F)**, which requires **1% of early ballots cast, or 5,000 ballots, whichever is less**. As of now, 5,260 early ballots have been tabulated, with approximately 800 pending verification. Calculation: $5,260 \times 0.01 = 52.60$ Rounded up, **53 early ballots** must be hand counted. Since most tabulated batches contain 50 ballots, **two batches** will be selected.

Lots labeled **A0001–A0109** will be used for random selection, with numbers indicated only on the coins. Exceptions include A0066, which was removed due to an administrative error and replaced with A0080. The highest number used, A0109, reflects the total number of batches available for processing on the day the random selection was conducted.

Selected batches will be sequestered and accompanied by individual tally sheets for each batch.
