GAME AND FISH COMMISSION

1. **Title and its heading:** 12, Natural Resources

- Section numbers:** R12-4-101, R12-4-103 through R12-4-105, R12-4-108, R12-4-109, R12-4-114, R12-4-119, R12-4-123, R12-4-216, R12-4-217, R12-4-307, R12-4-318, R12-4-511, and Section numbers to be determined for a new Article 7.
2. **Subject matter of the proposed rule:**
- R12-4-101 would be amended to add a definition for tags which are obtained other than through the drawing and to clarify unnecessarily narrow language.
- R12-4-103 would be amended to require persons to provide their Department identification number if requesting a duplicate for hunt-permit tag.
- R12-4-104 would be amended to clarify provisions allowing a "second deer" option tied to the hunt-permit tag application schedule and "remaining hunt-permit tags in unfilled hunt areas."
- R12-4-105 would be amended to clarify and improve criteria for obtaining this license, particularly the need for credit history. Renewal procedures should be improved while ensuring that the Department is advised of material changes in assets or liabilities. Another amendment would require the Department to begin cancellation of this license upon failure to remit monies owed within 30 days. Other proposals address operating requirements and would not require the Department to issue inventory (licenses) to a dealer not in compliance with applicable rules and laws.
- R12-4-108 requires amendment for housekeeping changes only, such as updating highway designations.
- R12-4-109 requires amendment to update wildlife areas.
- R12-4-114 would be amended in relation to change being made to R12-4-104 (the "second deer" provision); in addition, it is recommended that the tag design and the requirement to "punch out" the date and year on the tag be removed from this rule and related R12-4-301.
- R12-4-119 may be amended to add a third category of reserve.
- R12-4-123 is a new rule on expenditures under the control of the Director per A.R.S. § 17-231(A)(7).
- R12-4-216 is a proposed new rule which would allow use of a crossbow during archery-only season by persons with a disability which does not allow use of archery equipment. This permit would not allow use of a crossbow to take wildlife for which a crossbow is not currently legal during a general firearms season.
- R12-4-217 would be repealed and replaced with a new rule, the "Challenged Hunter Access Mobility Permit (CHAMP)", which would be issued to hunters with certain disabilities limiting their ability to hunt; it would allow permittees to fire from their parked vehicle which is not on a road and to designate an assistant in the field. See also the proposed amendment to R12-4-318.
- R12-4-307 would be amended to allow the use of box traps for predators and furbearers.
- R12-4-318 would be amended to create a hunt structure for holders of permits issued pursuant to R12-4-217 "Challenged Hunter Access Mobility Permit".
- R12-4-511 would be amended to conform to a new federal law.
New Article 7 would address the grant program, prescribing definition and general provisions, application procedures, eligibility criteria, proposal review methods, and grant-in-aid participation.

On May 19, 1995, the Commission may determine whether to approve a Notice of Proposed Rulemaking on any or all of these rules. A decision may also be deferred to a later Commission meeting; this would be announced at the May 19th meeting. If any Notice of Proposed Rulemaking is approved on May 19, it is planned that legal notice would be published in the *Arizona Administrative Register* on June 9 or 16, 1995. The Department would then take additional written comment and hold statewide public hearings (the dates and locations to be included in the *Register*). The targeted effective date would be January 1, 1996.
