

**EXECUTIVE ORDERS, PROCLAMATIONS OF GENERAL
APPLICABILITY, AND STATEMENTS ISSUED BY THE
GOVERNOR PURSUANT TO A.R.S. § 41-1013(B)(3)**

The Administrative Procedure Act (APA) requires the full-text publication of all Executive Orders and Proclamations of General Applicability issued by the Governor. In addition, the *Register* shall include each statement filed by the Governor in granting a commutation, pardon or reprieve, or stay or suspension of execution where a sentence of death is imposed.

**EXECUTIVE ORDER 95-4
COMPACT ADMINISTRATOR
INTERSTATE COMPACT FOR THE
SUPERVISION OF PAROLEES AND
PROBATIONERS**

WHEREAS, the State of Arizona entered into the Interstate Compact for the Supervision of Parolees and Probationers on August 8, 1973, with the several states of the United States; Arizona Revised Statutes, Section 31-461; and

WHEREAS, said Compact in part states: "...the governor of each state may designate an officer (Compact Administrator) who...shall...carry out the terms of the Compact;" and

WHEREAS, the Director of Corrections has been known as the Compact Administrator and has been responsible for said Compact since the State of Arizona enacted said legislation;

HENCEFORTH, be it known that the Director of Corrections, or his designee, is designated as the Compact Administrator for said Compact, with all rights, privileges, and powers pertaining;

NOW, THEREFORE, I, Fife Symington, Governor of the State of Arizona, by virtue of the authority vested in me by the Constitution and the laws of this State, transfer authority and responsibility for the above Compact to the Director of Corrections.

**PROCLAMATION BY THE GOVERNOR OF
THE STATE OF ARIZONA**

**Calling a First Special Session of the Forty-second
Legislature of the State of Arizona**

By the power vested in me by Article IV, Part 2, Section 3, and by Article V, Section 4, of the Arizona Constitution, I, Fife Symington, Governor of the State of Arizona, call the 42nd Legislature to meet in First Special Session in the Capitol on Tuesday, the fourteenth day of March, 1995, at 11:15 a.m.

The subjects to be considered at the special session shall be:

1. The general appropriations bill and the capital outlay bill for fiscal year 1995-1996, including appropriations for certain agencies for fiscal year 1996-1997.
2. Statutory and session law changes necessary to produce a balanced state budget for fiscal years 1994-1995, 1995-1996, and 1996-1997.
3. Statutory and session law changes which will produce net tax reductions in fiscal year 1995-1996 and fiscal year 1996-1997.
4. Supplemental appropriations for fiscal year 1994-1995.
