2. **Subject matter of the proposed rule:**  
A five-year review conducted in 1992 revealed that the rules governing state designation of Medically Underserved Areas (MUAs) were obsolete and needed to be updated. In 1994, the State Legislature amended the statutory authority for the rules, A.R.S. § 36-2352, to establish a new methodology for designating MUAs. These rules are proposed to affect the amendment to A.R.S. § 36-2352 which mandates ADHS to designate areas of medical need in the state as medically underserved if either the area is designated as a health professional shortage area as defined in 42 CFR 5, or the area is designated as medically underserved by ADHS using an index that measures underservice. These rules set forth the procedures for designating MUAs to include automatic designation of Health Professional Shortage Areas (HPSAs), identification of areas of the state eligible for MUA designation based on use of an index, use of the index to score and rank eligible areas, designation of those that are medically underserved, and creation of a database.
