

Register Deadlines

Laws, 1994, Ch. 363 substantially changed the rulemaking process in Arizona effective January 1, 1995. Beginning on January 20, 1995, the Secretary of State's Office will publish the *Register* weekly. The weekly deadline dates and issue dates are shown below. The Governor's Regulatory Review Council regular meeting dates are also shown following the *Register* deadline dates, based on the current schedule of one meeting per month. That could possibly change. Council meetings and *Register* deadlines no longer correlate. Deadline dates for Council meetings have not yet been established. The earliest dates on which public hearings can be held on proposed rulemakings or proposed delegation agreements following publication of the notice of the public hearing in the *Register* are also listed.
