VIOLENCE AGAINST WOMEN, GOVERNOR'S COMMISSION ON

The Commission membership will be limited to 30 members appointed by the Governor serving at the pleasure of the Governor. The Governor designates from among the membership an Executive Board and from among the Executive Board a Chairperson. One member of the Executive Board must be a representative of the Governor's Office for Women who will serve as Executive Director. The Commission submits a report of its activities to the Governor no later than November 1 of each year.

The Commission coordinates and develops the resources needed to aid the victims of violence or sexual assault; advises the Governor on proposed and existing legislation to protect the victims, ensures their rights, and prosecutes the abusers and assailants; educates the public to prevent the spread of violence and sexual assault; and conducts a multifaceted campaign to raise public awareness of the nature, consequences, and extent of violence against women in Arizona.
