

**EXECUTIVE ORDERS, PROCLAMATIONS OF GENERAL  
APPLICABILITY, AND STATEMENTS ISSUED BY THE  
GOVERNOR PURSUANT TO A.R.S. § 41-1013(B)(3)**

The Administrative Procedure Act (APA) requires the full-text publication of all Executive Orders and Proclamations of General Applicability issued by the Governor. In addition, the *Register* shall include each statement filed by the Governor in granting a commutation, pardon or reprieve, or stay or suspension of execution where a sentence of death is imposed.

**EXECUTIVE ORDER 95-1**

(Supersedes Executive Orders 76-11, 77-1, 85-10 and 91-19)

**CREATING THE ARIZONA GOVERNOR'S  
FILM AND TELEVISION ADVISORY BOARD**

WHEREAS, there is both private and public interest in film and television production as industries presenting a great potential for economic growth in Arizona; and

WHEREAS, both sectors wish to participate in a cooperative effort to channel these interests in a productive and effective manner; and

WHEREAS, it is desirable to establish an official procedure and formal organization within state government to address an advisory partnership;

NOW, THEREFORE, I, Fife Symington, Governor of the State of Arizona, by virtue of the authority vested in me as Governor of the State of Arizona by the Constitution and by statutes of this State, do hereby create the **Arizona Governor's Film and Television Advisory Board** and order and direct that:

1. The functions and purpose of the Board shall be:
  - a. To advise the Governor on suggested policy relating to the State's development, coordination, and implementation of programs to attract and embrace film and television production of both indigenous and imported genres. This effort shall be inclusive of all film and television production activities.
  - b. To support the Arizona Film Commission, as part of Department of Commerce, efforts to market Arizona as a location destination and production center, as well as to facilitate and support all film and television production throughout the State for the express purpose of economic growth.
  - c. To recommend both long-range and short-term programs, working in concert with the Arizona Film Commission, that will result in greater economic development for the State.
  - d. To support and assist educational efforts for state, local, and private officials and

organizations regarding the positive benefits resulting from increased film and television production and production business.

- e. To support legislation that will advance Arizona to the forefront of competition for increased production business within the international marketplace.
2. The Board shall consist of not more than 11 members who shall serve at the pleasure of the Governor. The Governor shall appoint the Board Chairman and Board Vice Chairman for a term coinciding with his term of office.
3. The Board shall meet at the call of the Board Chairman at such places within the State as the Chairman designates. The Board shall meet not less than once per quarter.
4. The Director of the Arizona Film Commission shall serve as the ex officio Chair. Other ex officio members shall be appointed to represent other film offices or organizations within the State of Arizona.
5. The Department of Commerce shall provide such staff service for the Board as required to carry out the purposes and functions of this Order.
6. This Order shall become effective immediately.

WHEREAS, the State Land Department requested supplemental funding from the State Emergency Council after expending its authorized funding; and

WHEREAS, on September 9, 1993, that State Emergency Council allocated \$200,000 for transfer to the State Land Department to help defray unpaid obligations; and

WHEREAS, the transfer of funds to the State Land Department was accomplished on December 15, 1993; and

NOW, THEREFORE, I, FIFE SYMINGTON, Governor of the State of Arizona, by virtue of the authority vested in me by the Constitution and Laws of the State, do hereby terminate, effective December 16, 1993, the declaration of the State of Emergency of February 2, 1995.

**PROCLAMATION**

**\*IN ACCORDANCE WITH ESTABLISHED  
EMERGENCY PROCEDURES\***

WHEREAS, beginning July 25, 1994, the Mohave County Board of Supervisors declared an emergency for the health, safety, and welfare of the citizens of Lake Havasu within Mohave County, Arizona, to prevent the

spread of contagious and communicable diseases, to prevent the threat of disease and spread of unsanitary conditions or environmental nuisances, and to protect the physical safety of the community; and

WHEREAS, the Department of Environmental Quality documented and Mohave County concurred that, in certain areas of Lake Havasu, fecal coliform rates were in excess of the State of Arizona standards; and

WHEREAS, it was necessary to determine the cause or source of the contamination that threatened public health and safety which constituted a grave emergency and was beyond Mohave County's capability to resolve; and

WHEREAS, the threat of disease has abated; and

NOW, THEREFORE, I, FIFE SYMINGTON, Governor of the State of Arizona, by virtue of the authority vested in me by the Constitution and Laws of the State, have determined that these unhealthy and unsafe conditions justified a declaration of a State of Emergency and hereby:

Amend the Proclamation of July 26, 1994, for the purpose of closing the incident period effective September 28, 1994.
