

Deadlines for Publication and G.R.R.C. Schedule

**Register Deadlines**

The Secretary of State's Office publishes the *Register* weekly. There is a three-week turnaround period between a deadline date and the publication date of the *Register*. The weekly deadline dates and issue dates are shown below. The Governor's Regulatory Review Council regular meeting dates are also shown following the *Code* dates. Council meetings and *Register* deadlines do not correlate. Also listed are the earliest dates on which public hearings can be held on proposed rulemakings or proposed delegation agreements following publication of the notice of the public hearing in the *Register*.
