2. **The subject matter of the proposed rule(s):**  
Maricopa County will propose to amend Rules 311 and 320 by repealing certain outdated sections that are pertinent to nitrogen oxides, sulfur dioxides, carbon monoxide and particulate matter standards emitted from fuel burning operations. These sections will be amended with source specific standards addressing these pollutants in new Rules 322 and 323. Rule 311 will further be amended by clarifying sections on Portland cement plants and recordkeeping retention time. Rule 320 will further be amended by deleting the exemption section in 311, revising the definitions of low and high sulfur oil and repealing the section on sulfuric acid plants since there are none of these sources in the

County. New Rules 322 and 323 will address power plant operations and combustion equipment such as steam generators, turbines and process heaters at other sources.
