PURSUANT TO A.R.S. § 41-1013(B)(3)**

The Administrative Procedure Act requires all Executive Orders and Proclamations of General Applicability issued by the Governor to be published in the *Arizona Administrative Register*. In addition, the *Register* shall include each statement filed by the Governor in granting a commutation, pardon or reprieve, or stay or suspension of execution where a sentence of death is imposed. *Spelling, grammar, and punctuation of these orders has been reproduced as submitted.*
