Rule 324 applies to existing or new stationary internal combustion engines with a rating of greater than 250 bhp that are compression or spark engines or to engines each with a brake horsepower of 50 bhp used at a single source whose maximum aggregate rated brake horsepower is greater than 250 bhp. The rule will be amended to address agricultural exemptions, addition of language to the definition of equivalent engine replacement, expansion of the definition of emergency engines to include an operating limit of 500 hours, separation of Method 202 from Method 5 and the addition of limits for the amount of sulfur in digester and landfill gas.
