PURSUANT TO A.R.S. § 41-1013(B)(3)

The Administrative Procedure Act (APA) requires the full-text publication of all Executive Orders and Proclamations of General Applicability issued by the Governor. In addition, the *Register* shall include each statement filed by the Governor in granting a commutation, pardon or reprieve, or stay or suspension of execution where a sentence of death is imposed. **WHEREAS**, in April of 1942, Allied Forces began flying missions from India over the Himalayan Mountains to supply Chinese forces fighting the Japanese; and

**WHEREAS**, these resupply missions in the China-Burma-India (CBI) theater of operations were among the most dangerous of World War II resulting in the loss of hundreds of aircraft and crew; and

**WHEREAS**, Clayton Kuhles has dedicated his time and resources to locate and document World War II aircraft and aircrews lost in the CBI theater; and

**WHEREAS**, to date Clayton Kuhles has located 15 U.S. aircraft crash sites, accounting for 106 Missing in Action U.S. aircrew members, including the Williams Air Force based crew of the B-24J Liberator, nicknamed "Hot as Hell"; and
