

**EXECUTIVE ORDERS, PROCLAMATIONS OF
GENERAL APPLICABILITY, AND STATEMENTS
ISSUED BY THE GOVERNOR
PURSUANT TO A.R.S. § 41-1013(B)(3)**

The Administrative Procedure Act (APA) requires the full-text publication of all Executive Orders and Proclamations of General Applicability issued by the Governor. In addition, the *Register* shall include each statement filed by the Governor in granting a commutation, pardon or reprieve, or stay or suspension of execution where a sentence of death is imposed. With the exception of egregious errors, content (including spelling, grammar, and punctuation) of these orders has been reproduced as submitted.

* NATIONAL ANTHEM DAY *

WHEREAS, “The Star Spangled Banner” was adopted as the National Anthem of the United States of America in 1931 by an Act of Congress; and [M09-327]

WHEREAS, recent surveys indicate that many Americans have limited knowledge of the origin of “The Star Spangled Banner,” its author, words, or significance; and

WHEREAS, the study of American heritage through music inspired by important moments in our nation’s history is basic to a complete education; and

WHEREAS, patriotic songs taught in schools across Arizona and the nation provide lessons and tales of our history and promote our heritage.

NOW, THEREFORE, I, Janice K. Brewer, Governor of the State of Arizona, do hereby proclaim September 14, 2009 as

and encourage all Arizonans to celebrate the history of “The Star Spangled Banner” and learn more about the events surrounding the creation of our great nation.

WHEREAS, the Act entitled “An Act to establish the Judicial Court of the United States,” approved September 24, 1789, directed the appointment of United States Marshals and launched the United States Marshals Service; and [M09-332]

WHEREAS, during 220 years of service, United States Marshals have executed warrants, distributed presidential proclamations, registered enemy aliens in time of war, helped conduct the national census, protected the President and the Federal courts, provided for the custody and transportation of Federal prisoners, and maintained and disposed of seized and forfeited properties; and

WHEREAS, the United States Marshals have also ensured the safe conduct of judicial proceedings, protected Federal judges and jurors and other members of the Federal judiciary, provided for the security of witnesses and directed and coordinated fugitive task forces to apprehend dangerous fugitives; and

WHEREAS, as part of the Service’s national history, the Office for the Territory of Arizona was established on February

24, 1863, followed with the June 20, 1910 creation of a District of Arizona, which subsequently became effective on February 14, 1912; and
