

**Deadlines for Publication and G.R.R.C. Schedule**

**2010 Effective Dates**

A.R.S. § 41-1032(A), as amended by Laws 2002, Ch. 334, § 8 (effective August 22, 2002), states that a rule generally becomes effective 60 days after the day it is filed with the Secretary of State's Office. The following table lists filing dates and effective dates for rules that follow this provision.

The weekly deadline dates and issue dates are shown below. **Council meetings and Register deadlines do not correlate.** Also listed are the earliest dates on which an oral proceeding can be held on proposed rulemakings or proposed delegation agreements following publication of the notice in the *Register*.
